Personally know what to do during disasters

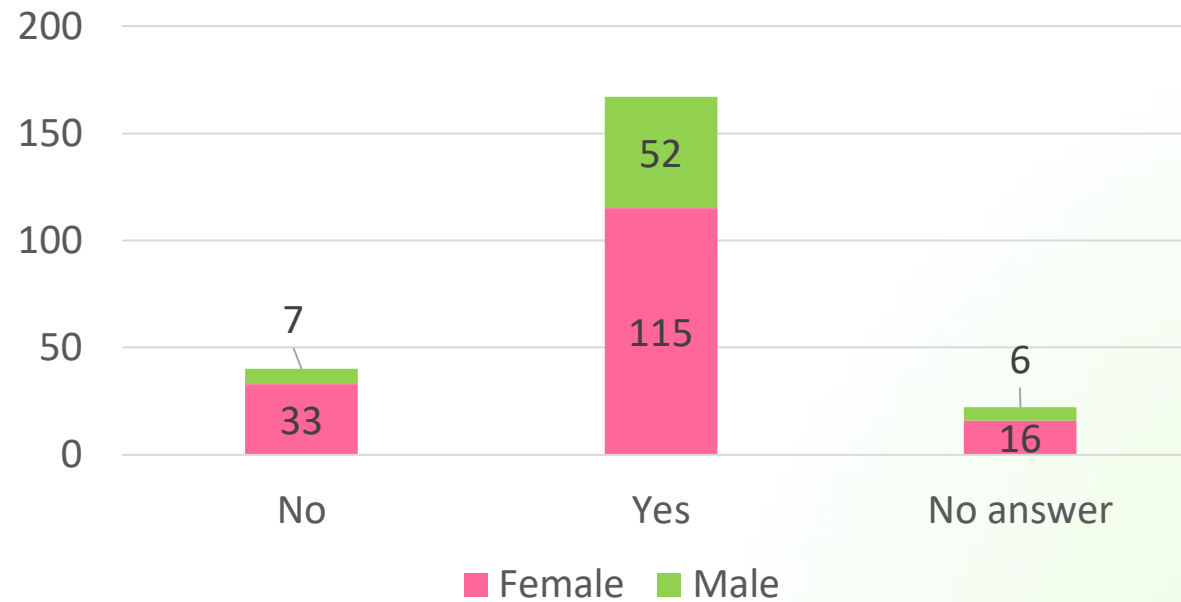


Personally know what to do during disasters as a group, together with family members



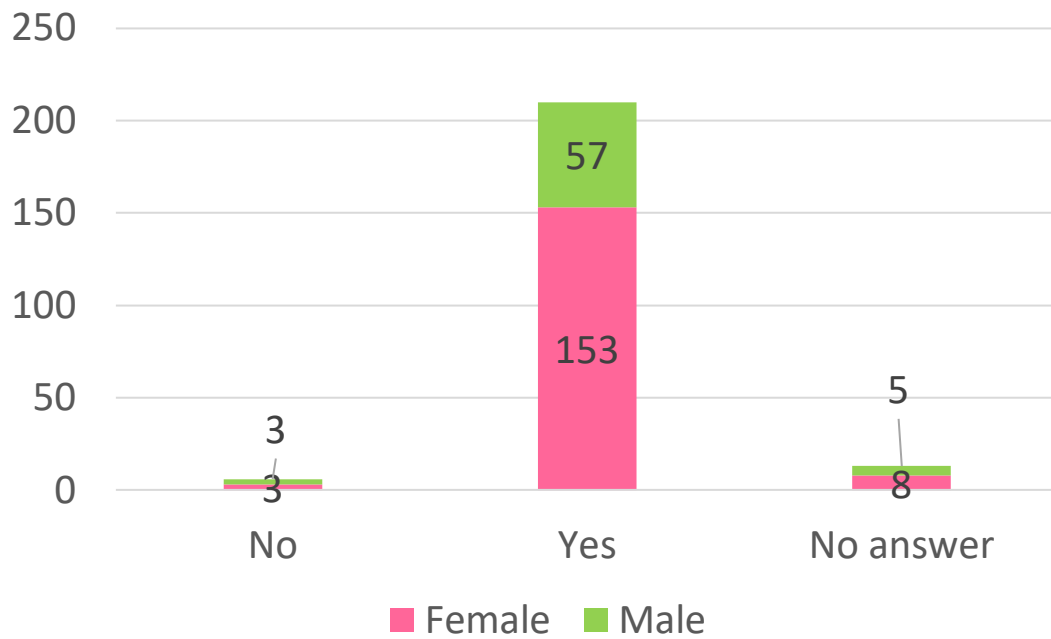

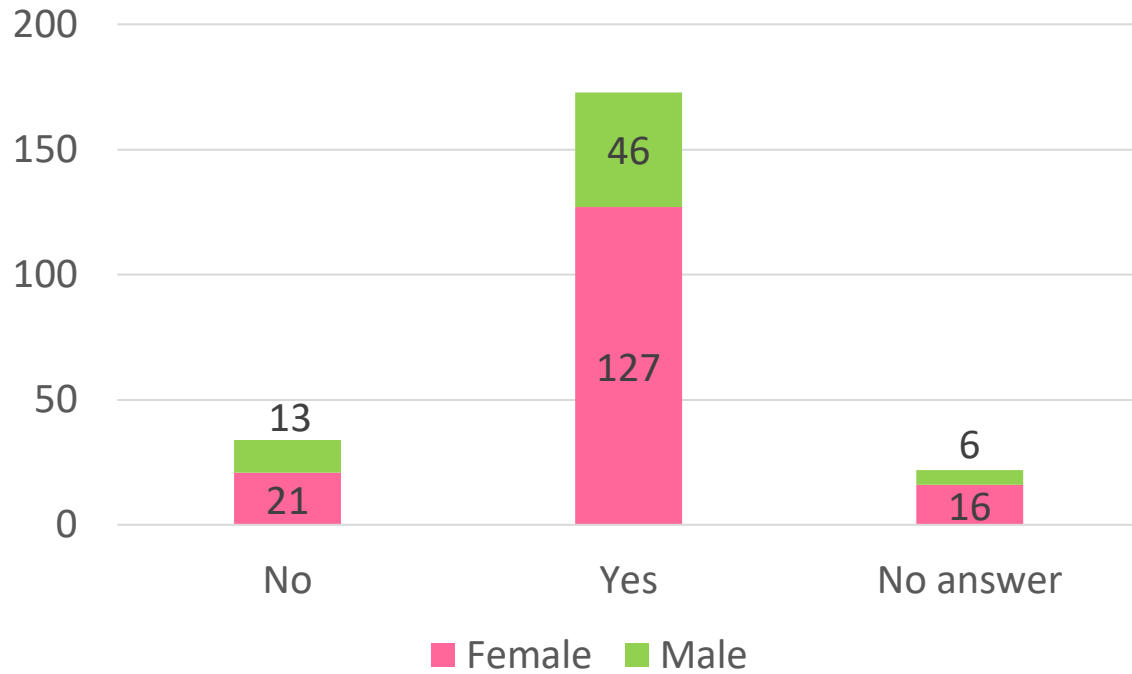


Consulted regarding work area at the workplace
